S-01 | Understanding Harm: The Real Landscape

- ▶▶ Active vs latent errors — anatomy of a harmful event
- ▶▶ System vs individual blame frameworks
- ▶▶ Near-miss blindness in hospitals
- ▶▶ Why harm reoccurs and how to address
- ▶▶ Small hospitals fail because warning signals are ignored.

S-02 | The Hidden Cost of Unsafe and Poor Quality Care

- ▶▶ Financial exposure from adverse events
- ▶▶ Real case narratives: infection cluster, ICU power failure, litigation
- ▶▶ Reduction in length of stay: Economic analysis and action plan
- ▶▶ Table activity: Economic impact of preventable events
- ▶▶ Unsafe care is expensive care. Safety = margin protection.

S-03 | Leadership Behaviours That Create Safe Hospitals

- ▶▶ Owner behaviour as the primary culture driver
- ▶▶ Safety reviews, walk rounds, transparent dashboards
- ▶▶ Psychological safety and just culture principles
- ▶▶ Self-assessment rubric (1–5 scale, 5 dimensions)
- ▶▶ Safety is not a policy. It is owner behaviour.

S-04 | Infrastructure Safety: Preventing Catastrophic Risk

- ▶▶ Electrical overload, oxygen pipeline failure
- ▶▶ Fire compliance gaps and equipment maintenance
- ▶▶ Legal, insurance, and regulatory consequences
- ▶▶ Table exercise: identify your top infrastructure risk
- ▶▶ One infrastructure failure can close your hospital permanently.

S-05 | Practical Tools for Immediate Implementation

- ▶ Clinical: surgical checklist, SBAR, consent templates
- ▶ Operational: risk register, maintenance log, safety dashboard
- ▶ Cultural: anonymous incident reporting, safety huddles
- ▶ Output: each hospital commits to 3 tools in 90 days
- ▶ Implementation beats perfection. Start with three tools.

S-06 | Digital Adoption: Safety Multiplier & Business Enabler

- ▶ Digital as legal protection, not IT aspiration
- ▶ Minimum stack: EMR, e-prescription, incident reporting system
- ▶ Billing leakage, documentation disputes, medication errors
- ▶ AI and ML in Promoting Quality and Patient Safety
- ▶ Digital is risk mitigation. Paper-based systems = unprotected.

S-07 | Crisis Simulation: When Things Go Wrong

- ▶ Live scenario: post-surgery death + ICU failure + social media
- ▶ Build: 60-min response plan, communication plan, legal steps
- ▶ Debrief: documentation integrity, leadership under pressure
- ▶ Digital audit trails as medico-legal protection
- ▶ If your hospital cannot survive one bad day, it is not resilient.
